"AYRLITE 2084"

is a panel comprising of an aluminium honeycomb core with cell diameter of 6.35mm faced with an aluminium sheet of min. thickness 0.8 mm with decorative vinyl facing (max. thickness 0.15 mm).

Min. overall panel thickness: 6 mm

Application/Limitation

Approved for use as low flame spread surface material, not generating excessive quantities of smoke nor toxic products in fire

Approved for all colour variations.

Max. organic content: 56 %

Approved for use as decorative veneer on any metallic base and non-combustible base.

Any adhesive used, other than the one used during testing, has to be tested for low flame spread characteristics according to IMO FTP Code Part 5 and be approved according to the Marine Equipment Regulation and bear the Mark of Conformity.
